Provisions and the execution steps of the Alternate Graduation Path (AGP) for the students close to graduation

1. The graduating students are identified as students who are short of the minimum graduate requirements by (program-wise) credits given below and are currently registered in at least those many credits:

B. Tech + Dual Degree : 37 credits including the summer semester registration (=28+9)

M. Sc.: 26

M. Tech. / M. Des. / MBA (Full Time) : 15

M. Tech. / M. Des. / MBA (Part Time) : 12

PG DIIT: 20

Any student on exchange/ visiting to IIT Delhi

- 2. A list of the graduating students will be provided as a link to the Institute's webpage. Only students appearing in the list will be able to avail AGP through a portal which will be enabled from June 08, 2020. All the graduating students are strongly advised to have a look at the list and in case you satisfy the above criterion and your name is not in the list, contact arugs@admin.iitd.ac.in before 5:00 PM on June 08, 2020.
- 3. Each student has 3 options to complete the graduation requirements. The AGP provides two options and a student can choose not to opt for the AGP and complete the degree when the semester reconvenes for all students.
- 4. All the course content delivery and evaluation in the AGP are in online mode and students are not required to come to campus for completing courses. The remaining course content delivery and pre-final evaluations, if any, will be done in the period from June 01, 2020 to July 03, 2020. It is a good idea to frequently check your IITD email account and login to Moodle as the course coordinators may be using these and other modes to deliver course content or any other information related to course. Kindly make necessary arrangements for accessing the course content and for attempting evaluations.
- 5. The two options available in AGP are:
 - i. Audit all courses registered in current and summer semesters.
 - ii. complete all courses registered in current and summer semester as Credit courses.

For exercising the option, the courses are divided into two categories: project courses and non-project courses. A student has freedom to choose any of the two options for each category of courses, i.e., a student can choose option (i) for project courses and option (ii) for non-project courses or vice versa, or she/he can choose the same option for both category of courses. Following additional freedom is also provided:

- a) A UG student choosing option (ii) is allowed to Audit courses up to 8 credit including any courses Audited in the previous semesters. This is as per existing rule given in Courses of Study.
- b) There is no restriction on number of Audit courses done for completing the requirements of the Minor degree.
- c) While Major project is definitely a project category course, a student can choose to club independent study, mini project or minor project courses in either category. If no choice is exercised, then by default, they will be put in the non-project category of courses. This information, if relevant, may be put in the "Remarks" field that you will see in the relevant place once you log in to the portal.
- 6. For major project course, the choice of Audit/ Credit should be made in consultation with the project supervisor.

- 8. The course evaluation policy for AGP (which may be different from the original course policy) will be available in the Academics ERP system well before the window for you to exercise your choices.
- 9. A portal will be provided for i) choosing the AGP options, ii) withdraw from any course, iii) apply for Minor Degree, and iv) request change in course category. The portal will be available from June 08, 2020 to 5:00 PM on June 14, 2020.
- 10. If a student does not fill the required options in the portal, then she/ he cannot opt for the AGP and has to complete the graduation requirements when the classes reconvene. That will remain the default option.
- 11. The choice exercised in the portal will be final and cannot be changed later. It is a one-time choice so please exercise your options carefully.
- 12. A uniform course evaluation policy is applicable irrespective of a student's choice of doing the course on Credit or Audit.
- 13. For Major Project courses, submission of the project report and final presentation is required. The report submission will be online/ through email and exact details will be informed in due course by your project course coordinator.
- 14. Provision of I grade exists and makeup evaluations exists in AGP.
- 15. In case a student chooses AGP, but fails to graduate, then she/he will have the chance to complete graduation requirements by completing the courses with other students as and when the semester reconvenes.
