MEMORANDUM OF UNDERSTANDING BETWEEN PRADEEP SINGH AND IIT DELHI FOR CREATION OF "BRIGADIER BHOPINDER SINGH CHAIR" AT IIT DELHI.

This Memorandum of Understanding is made between **Pradeep Singh, CEO, Aditi Corp., 20006, NE 39th St., Redmond, WA, 98053, USA** and the **Indian Institute of Technology, Delhi**, having its office at Hauz Khas, New Delhi (India) herein referred to as "IITD" witnesseth as follows: -

1. **Title**

The perpetual position of Professor will be designated as ***Brigadier Bhopinder Singh Chair.***

2. **Objective**

The main objective for which the perpetual position of Brigadier Bhopinder Singh Chair will be created is to promote Research and academic work in the field of Computer Science Technologies so as to expand the knowledge, insight and skills of the technical professionals.

3. **Grant for the Chair**

Pradeep Singh will deposit with IITD a sum of **US \$ 115,000/- (US dollars One hundred fifteen thousand only)** as one time grant. The equivalent **Rs. 40,00,000/- (Rupees Forty Lakhs Only)** will be taken as lump sum endowment to IIT Delhi. The sole purpose of this endowment would be to partially support the position of **Chair Professor at IITD**. The remaining amount will be utilized for partially developing the Cyber-Cafe in Kumaon Hostel at IITD.

4. **Utilization of the Grant**

The earnings from the endowment of Rs. 40.00 lakhs will be utilized only for meeting the expenditure involved in attaining the objective stated above.



5. Mode of Selection and Appointment of Professor

A Committee consisting of the following will recommend to IITD, the Professor to be appointed to the **Chair**:

- a) Director, IITD Chairman
- b) Two nominees of the BoG
- c) One nominee of the donor
- d) Deputy Director (Faculty)

The **Brigadier Bhopinder Singh Chair** is expected to fulfill the normal obligations of a **Professor in the Department**, with research and development efforts oriented towards the objective of the Chair.

The **IITD** shall take steps to ensure that **the Brigadier Bhopinder Singh Chair** is appointed as early as possible.

6. Tenure


The tenure of the **Brigadier Bhopinder Singh Chair** will **not exceed five years** at the time of appointment and subsequent extensions each for a further period of up to **five years** will be subject to the review of the performance judged as satisfactory by **IITD appointment Committee**.


7. Presentations of the work done

Once in two years, the **Brigadier Bhopinder Singh Chair** should present his work in public, the place being chosen by **IITD appointment Committee**.

This MoU is signed subject to approval of the appropriate authorities on both sides.
