Subject: Regarding recruitment for the post of Horticulture Officer at IIT Delhi.

The Institute vide Advt. No. Mission Mode (DR) (1) / 2023 dated February 02, 2023, invited online applications for filling-up 01 post (i.e. 01-UR) of Horticulture Officer in Level-6 of Pay Matrix as per 7th CPC for Estate & Works, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the candidates in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria as mentioned in the advertisement, has been adopted by the Shortlisting Committee to scrutinize the applications of the candidates:

Essential:

B.Sc in Agriculture or Botany or Horticulture from a recognized university or Institute with atleast 55% marks; and possessing two years' experience in Horticulture including ornamental gardening in any Government Department or autonomous or statutory body or PSU or in any company incorporated under companies Act, 2013 or listed in stock exchange ;

OR

M.Sc in agriculture with specialization in Horticulture or M.Sc in landscape architecture or floriculture from a recognized university or Institute with atleast 55% marks.

Based on the criteria mentioned above, **80** candidates have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that candidates have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
