The following essential criteria was mentioned in the advertisement:

Essential:

M.Tech. Degree in Engineering (MS(Research)/M.E.) or equivalent qualification in any specialization in Civil/ Mechanical/ Textiles/ Biotechnology/ Chemical/ Biochemical/ Electrical/ Electronics/ Communication/ Instrumentation/ Computer Science with a minimum of 55% marks in the qualifying degree from a recognized University/ Institute with 02 years regular/permanent relevant experience.

OR

Master's Degree in Science (Physics/ Chemistry)/ Computer Science/ Computer Applications or Bachelor's Degree in Engineering (BE/B.Tech) or equivalent qualification (AMIE) in Civil/ Mechanical/ Textiles/ Biotechnology/ Chemical/ Biochemical/ Electrical/ Electronics/ Communication/ Instrumentation/ Computer Science with a minimum of 55% marks in the qualifying degree from a recognized University/ Institute with 04 years regular/permanent relevant experience.

OR

Bachelor's Degree in Science (Physics/ Chemistry)/ Computer Science/ Computer Applications or equivalent qualifications in appropriate field with a minimum of 55% marks in the qualifying degree from a recognized University/ Institute with regular/permanent 05 years relevant experience.

<u>In addition to essential qualification, the Committee decided to adopt the following criteria for shortlisting purposes:</u>

The regular/permanent experience of working under Central / State Governments/ UTs/ their Universities or Institutions/ Autonomous bodies/ Government laboratories/ Statutory organizations/PSU/PSE after essential Qualification will be considered.

Based on the criteria mentioned above, **852** applicants have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicants have furnished false or wrong information, their candidature will be rejected at any time/ any stage.
