

MEMORANDUM OF UNDERSTANDING BETWEEN
ALL INDIA COUNCIL FOR TECHNICAL EDUCATION &
THE HOST INSTITUTION

This Memorandum of Understanding (MoU) is executed at New Delhi on this 9th day of April, 2000 between the All India Council for Technical Education, Indira Gandhi Sports Complex, I.P. Estate, New Delhi - 110 002, hereinafter to be called and referred as AICTE, through its authorized representative Prof. I.K. Bhat and IIIT - Delhi hereinafter to be called and referred as Host Institution (HI), through its authorized representative Prof. V.S. Raju, Director

1. Preamble

The AICTE has formulated a new scheme called "Early Faculty Induction Programme (EFIP)", with a view to attract young and bright under-graduate students in Engineering & Technological to the teaching profession. The modus operandi of the scheme is as follows:

A few select Institutions, hereinafter to be referred as Receiver Institutions (RI) will screen through a procedure approved by AICTE, candidates for a National level examination to be conducted by AICTE, for final selection of a Teaching Fellow to be appointed after their post-graduate studies as full-time lecturers in RI for a minimum period of three years.

These candidates will be bright young under-graduate students pursuing their seventh semester of programme in any AICTE approved Institution in the country. Every selected candidate, hereinafter referred as Teaching Fellow (TF), will undergo a post-graduate study in a premier Institution in the country, hereinafter referred as Host Institution (HI).

The selected candidate will be required to fulfill the admission criteria for Postgraduate Programme at the HI. In case, a candidate fail to meet the requirement of the HI, the concerned candidate will cease to continue in the Postgraduate Programme.

The TF will receive a fellowship of Rs. 10,000 per month, starting from the beginning of the last semester of their under-graduate study. The duration of the programme is two years starting from the last semester of under-graduate study, till the end of the post-graduate study at the HI, inclusive of the period of vacation, the amount of fellowship will be Rs. 10,000 per month. The successful TF shall be offered admission in the post-graduate programme for the academic session 2000-2001, provided he/she satisfied all the eligibility criteria of the AICTE as well as HI, subject to the availability of seats in each discipline. The continuation of fellowship in subsequent semester, will however be governed by the rules of the Host Institute.

2. Function of AICTE and Host Institutions under the programme.

- AICTE agrees mutually with HI to utilize the expertise, manpower and facilities available with HI, so that the objective of training of TF under the EFIP can be achieved effectively.
- The HI agrees to extend to AICTE its expertise, manpower and facilities for training of TF under the scheme.
- AICTE agrees to facilitate training of TF selected by the RI at any of the few selected HIs.
- The HI agrees to reserve seats for training of TF and the number of seats to be reserved under the EFI Programme shall be intimated to HI by AICTE on or before a specified date.
- The HI shall admit such candidates only who have completed their B.E./B.Tech. in all respect i.e. their results have been declared.
- The AICTE agrees to allot the TF to the HI for undergoing training in ME/M. Tech. Programme. The AICTE agrees to bear academic expenses such as tuition fees, laboratory fees, library fees etc. of the TF and detailed estimate shall be provided to AICTE by the concerned HI latest by the first week of August to enable the AICTE to release funds either in one or two installments. Other expenses of a TF i.e. hostel charges, boarding and lodging expenses, breakage charges etc., if any, shall be borne by the respective TF.

- The HI agrees to include in the course curriculum for the TF some aspects on educational technology, teaching pedagogy, teaching practice and industry exposure in addition to usual post-graduate curriculum.
 - The HI agrees to take responsibility for accountability of finance/grants sanctioned under the EFI Programme and shall abide by the terms and conditions stipulated by AICTE for financial grants sanctioned to HI.
 - The HI shall submit accounts within two months of end of each financial year in respect of each TF allotted to the HI and shall return any unutilized funds available.
 - The HI shall release/make payments of fellowship as specified in the EFIP scheme to the TF by the way of crossed cheque on monthly basis against receipt on or before fifth day of each month.
 - The HI shall abide by any other terms and conditions of the EFI Programme as amended from time to time by AICTE.

3. Purpose of MoU

The purpose of the Memorandum of Understanding is to fulfill much needed proper academic and functional co-ordination required between AICTE and HI for successful operation of EFIP.

4. Review of MoU


These arrangements shall be effected for the batch selected during 2000-2001, commencing from the date of signing of this MoU and its continuance will be subject to review and/or review of these arrangements shall be subject to AICTE policy. Its rules, regulation, bye-laws and guidelines formulated for this purpose prevailing at that time.

This MoU will supersede all earlier MoU/Agreements between AICTE and IIT Delhi.

The AICTE and the HI shall be bound by the terms of this MoU.
